# Possible Implications of Academy of Alameda Middle School (AAMS) Charter

Board of Education February 9, 2010



### Background

- Chipman Middle School is in No Child Left Behind (NCLB) Program Improvement, Year 4
- As required, the school invested time to pursue options as outlined by NCLB
- Through a process of restructuring, the school submitted a charter school petition
- Charter petition was submitted to AUSD on October 27, 2009
- The governing board held a public hearing on November 10, 2009
- The governing board unanimously approved the Academy of Alameda Charter School on December 15, 2009



#### **Board of Education Updates**

- On May 12, 2009, the Board heard a Chipman Program Improvement update where the school determined two restructuring options:
  - close school and reopen as a charter school, or
  - close school and reopen it as a focus or theme school with new staff or staff skilled in focus area
- Series of community meetings focused on Chipman program improvement restructuring from May 11-June 17
- September 22, 2009: Chipman program Improvement Status Report
- September 29, 2009: Special meeting-Fiscal Update on Program Costs and the Chipman Middle School Charter Conversion

#### **Recap of Facts**

- Chipman is in Program Improvement Year 4. Federal law requires that AUSD identify a "restructuring plan".
- Academy of Alameda is a result of a restructuring process to address NCLB program improvement compliance
- If AUSD were not supporting the Academy of Alameda's charter as our restructuring plan, AUSD would have to identify another restructuring plan or close the school.
- If families do not select Academy of Alameda, we will prepare for changes to enrollment numbers at other sites.
- Under Prop 39 regulations, AUSD has offered the Academy of Alameda classroom space at Chipman School.
- Academy of Alameda is a free public charter school.
