Article 14 Vacation Plan

The District proposes to make changes to Article 12 that would achieve cost savings and/or improve the efficiency of District operations.

Article 15 Leaves

The District proposes to make changes to Article 15 to clarify ambiguous terms and improve the efficiency of District operations.

The District will supplement these proposals with more detailed information as the District formulates and presents proposals to CSEA 27.
