Enrollment Policy – Transfers due to over enrollment

- Parents notified in writing at registration

- Ask for voluntary transfers

- Involuntary transfers redirected to other schools, based on enrollment date
 - Students on interdistrict and Allen Bill permits first
 - Redirected students (intra districts) if all the following conditions are met:
 - There is a demand on their space at the current school by a resident living within the school boundaries, and
 - There is space at the redirected student's home school, and
 - Within the first two years of being redirected. After two years, redirected students may remain at the school of attendance through the 5th, 8th or 12th grades.

 - Students residing in attendance area last
