## NCLC Revised Petition: Addressing AUSD concerns

- NCLC petitioners appreciate the previous charter review proceeding
- We fully incorporated the feedback from that review process with AUSD and the Alameda County Board of Education
- This NCLC charter petition addresses all of these concerns and continues the vision of the Alameda community

#### **Revised Petition: Completely Independent of AUSD**

- NCLC will be a fully independent school
  - Charter petition makes NO assumption of service agreement with AUSD
  - NCLC has engaged EI Dorado SELPA to provide special education services
- Our ideal choice is a mutually beneficial arrangement with AUSD, but plans are in place for an alternative

## **Revised Petition: Comprehensive K-5 Curriculum**

- Petition includes a 300+ page course guide for the elementary school curriculum, addressing each grade.
- Educational model is based on internationally recognized educational programs in Ontario, Canada, the Columbia Teachers' College, and the Alameda Community Learning Center.
- This detailed curriculum adheres to California curriculum standards in all grades.

#### **Revised Petition: Transparent, accountable governance structure**

- NCLC petitioners developed a governing structure founded on the principles of democracy and responsibility.
- Petition includes comprehensive details on NCLC Governing Board, including scope of responsibility, selection, conflict resolution procedures, and board accountability.

# **Revised Petition: Representative of Alameda**

- NCLC strives to be an accurate representation of Alameda's student population in all respects and pledges to make every effort to achieve this goal.
- We have already started our targeted outreach efforts, which include:
  - Advertisements in non-English community papers
  - Outreach efforts at community center and gathering places specific to individual communities
  - Active engagement with several West End organizations to publicize the new school.
- NCLC cannot make racial or ethnic distinctions in our admissions policy, but we are committed to ensuring our applicant pool reflects the diversity of Alameda.

# **Revised Petition: Respected accounting and auditing procedures**

- NCLC will be a financially viable, financially transparent, and financially accountable institution.
- Worked with EdTec, the premier school financial accounting firm, to develop our revenue and cost projections based on commonly used education finance assumptions.
- Auditing procedures are clear and comprehensive and include provisions to address deficiencies or exceptions and resolve these items with the chartering agency.
